Wilson Schools Career Day at Mercy



Wilson, OK is a rural community west of Ardmore. The population of this community is just above 1,700 people. Students there don't have the luxury of learning about their many possible career choices. Around 50 middle school students (6th and 7th graders) visited Mercy Hospital Ardmore to spend time with some of our teams and to hear about other career opportunities offered by our community partners. The students met co-workers from pulmonary rehab, surgery, physical therapy, radiology, heart & vascular, EMS and more. The students left with a greater understanding of the rewards of a health care career. Since many health care careers are in high demand and have predicted shortages for the future, we plan to host students each year on campus to expose them early to these possible careers.
