### **GHX Vendormate Software**

Vendors log into our portal and complete a brief questionnaire which defines their relationship with Mercy. Based on key factors (i.e., the critical need for a product or service; a company's need to access patient data or a rep's need to access a procedural areas) the vendor is classified into risk categories that meet industry recommendations prior to gaining the authorization to print a badge to enter the hospitals. In order to complete a registration, vendors must submit the required Mercy policies and documents.

New vendors and representatives can register for the Mercy vendor program by navigating to registersupplier.ghx.com.

Mercy staff can log into the Mercy vendor program by navigating to login.ghx.com once they have been granted access.

### **Vendor Risk Criteria and Fees:**

One fee per vendor Tax ID includes all representatives that serve us. All representatives from one company share the same corporate level requirements and information.

High Risk: \$335 per vendor Tax ID (unlimited number if reps) - ACCESS PROCEDURAL PATIENT CARE AREAS, HAVE DIRECT PATIENT CONTACT, PHARMACEUTICAL VENDORS

Medium Risk: \$145 per vendor Tax ID (unlimited number if reps) - NOT IN PROCEDURAL PATIENT CARE AREAS & NO DIRECT PATIENT CONTACT & NOT A PHARMACUETICAL VENDOR

Low Risk: \$25 per vendor Tax ID (unlimited number if reps) - NOT IN PROCEDURAL PATIENT CARE AREAS & NO DIRECT PATIENT CONTACT & NOT A PHARMACUETICAL VENDOR AND ANNUAL SPEND IS BELOW \$5,000

## **Mercy Badge Rules:**

- 1. Badge is denied if there is a match on a sanction list
- 2. Badge is denied if representative is not registered for the vendor program
- 3. Badge is denied if representative is not fully compliant with missing or expired documents
